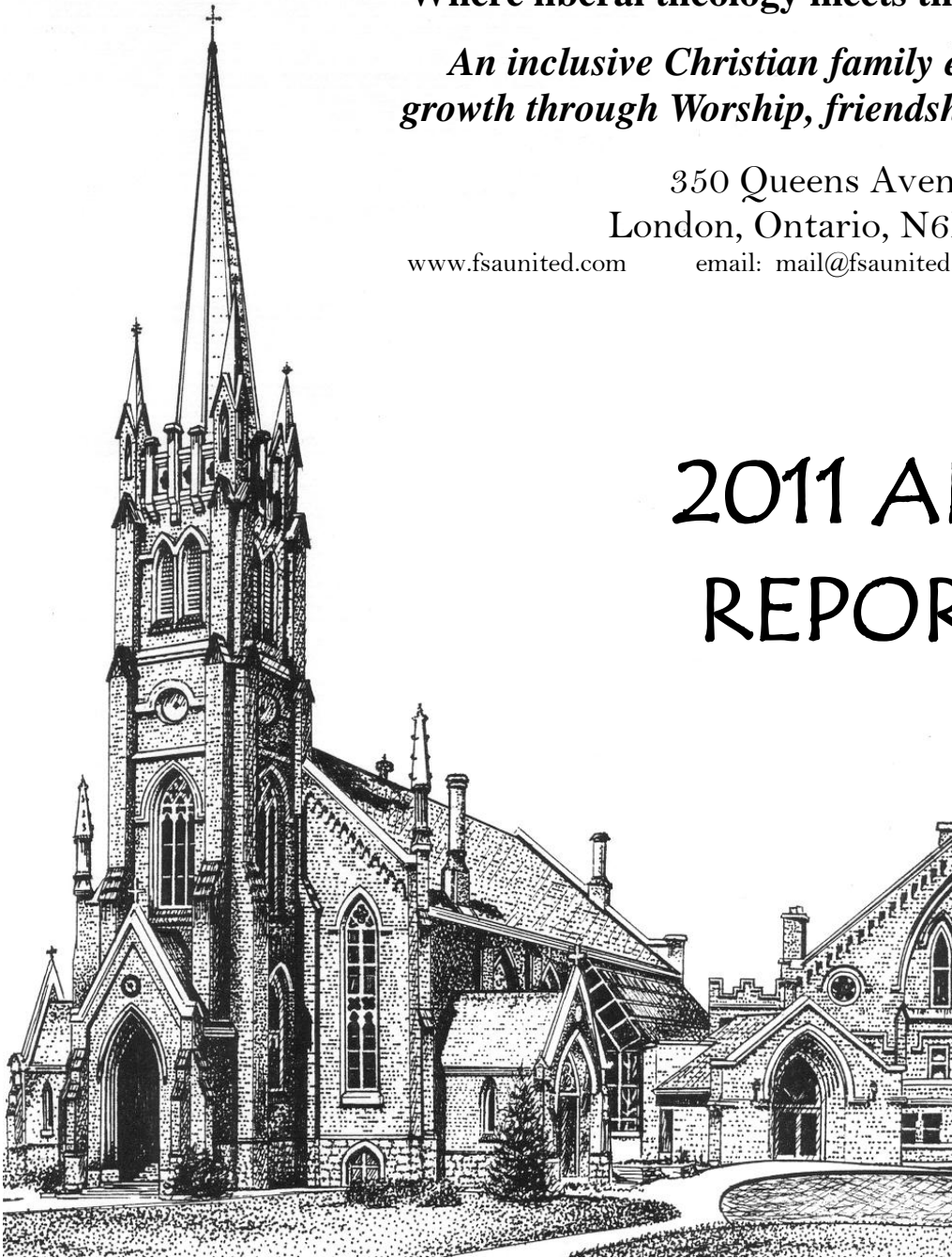

ANNUAL CONGREGATIONAL MEETING MINUTES - FEBRUARY 13, 201155

FROM THE MINISTER OF WORSHIP AND ADMINISTRATION AND PASTORAL CARE

For I am convinced that neither death, nor life, nor angels, nor rulers, nor things present, nor things to come, nor powers, nor height, nor depth, nor anything else in all creation will be able to separate us from the love of God in Christ Jesus our Lord. (Romans 8:38-39)

Brothers and Sisters,

This year is my first full calendar year in ministry with you, and also includes the first 12-month period that I have served with you, from August 2010 to August 2011. It certainly was busy!

During 2011 we bid farewell to two long-serving staff members, the Rev. Susan Shelstad, our Minister of Christian Development, and Susan Scorgie our Church Administrator. Easing their transition off our staff team, and facilitating the integration into the team of two new staff members has been a key component of my administrative role this year. We were so pleased to welcome a temporary, part-time Minister of Christian Development and Pastoral Care, in the Rev. Tom Hiscock, and new Church Administrator, Debra Low. I was also covering all clergy roles within the pastoral charge for the six months from January to June, with much help from willing volunteers, and the kind forbearance of those who had to wait for me to get jobs done!

Within our pastoral charge I offer leadership in all worship services, preaching at the majority. I also regularly support and attend the following: Council, Communications and Marketing, Worship, Trustees, Stewardship, Nominations and MOE. This year I also tried to attend as many of the following as I was able, until Rev. Tom arrived: Christian Development, Property, Membership and Nurture, Family Potluck suppers and Supper Club.

Beyond committee meetings I also visited in hospitals and homes, conducted funerals (we had some hard losses this year), and weddings as usual. I took on leadership of the Thursday Morning Bible Study, and the Confirmation class. I continued support and training of the fine team of Lay Leaders who assist in worship, worked with the Ministry and Personnel Committee on two special projects, refining the terms of the Clark Fund for Education and drafting a new Staff Handbook. I assisted the small Proudfoot Lecture group in welcoming Bishop John Shelby Spong in the fall, and also assisted the Worship Committee in welcoming the Rev. Ann Corbett for our Anniversary service. On behalf of Council I attended a "Faithful Readiness" workshop, for emergency preparedness, and walked in the London PRIDE parade.

Ministers also contribute at the Presbytery and Conference levels of our court system. I attend presbytery meetings bi-monthly, and Women in Ministry lunches monthly. I also serve on the Pastoral Oversight Committee, as well as the 75 Blackfriars Visioning Committee. My involvement at Conference was limited to attending the annual meeting, held in Sault Ste. Marie in May.

I have also been engaged in the wider community of London and beyond. I attend a community clergy lunch when I am able. I continue a very rewarding involvement with the Multi-faith Social Action Coalition, which was active in both the Provincial and Federal elections of 2011, as well as the Occupy London movement. I was invited to be the anniversary speaker for the London presbyterial of the UCW at Lambeth in February, and a lunch-time speaker at the Lenten series at Metropolitan United Church. I accepted an invitation to be involved in the Interfaith Dialogue Institute of London (a Turkish friendship group), and began conversations with the London Mosque which have led to a meeting between our

Council and their Board early in 2012, and took part in an interfaith conversation on suffering hosted by the London Free Press. I also represented FSA nationally when I gave a workshop on preaching at “Worship Matters” in Toronto in June, and had an article on ministry published in “Touchstone” magazine.

Lastly, I am grateful to thank you for the three weeks of leave which you afford me, with financial support, so that I am able to attend seminars and workshops which strengthen my ministry. This year I attended the Festival of Homiletics in Nashville, TN, in May; Berwick United Church Camp in August in Nova Scotia, where I am the Worship Superintendent; and Ministry in Motion, a conference on transformation leadership held in Burlington, Ont. in October.

In all these efforts I feel most blessed to be called to work with you, among you and for you in the service of Jesus Christ. My understanding is that my job is to ‘make disciples,’ and I measure my success by your engagement, vitality and joy in your own ministries. Thank you for allowing me to walk with you through this last year.

FROM THE PART TIME SUPPLY MINISTER

It is with great joy I submit my report for the second half of 2011, as Part-Time Supply Minister. This 20 hours per week position encompasses pastoral care, Christian Education and pulpit supply as required. During July and August orientation and pulpit supply were my prime responsibilities. Every church has its own way of operating and everything was new. FSA reliance on computers was a challenge at first but I am finding my way after six months. In September I met the Christian Development Committee and my work shifted to supporting Christian Education in the congregation. I have been going out of worship after the Children’s Time to be with the youth during church. A significant part of that time this fall was spent planning the Youth Service for December. It seems to be helpful to release ministerial staff to work directly with the Sunday School. Visitation has been accomplished around other requirements of the position. I have made 55 formal visits on your behalf during this period of time. As part of the staff team I have conducted 2 funerals, several weddings, four bible study sessions and a course on Structures of the United Church of Canada. As part of FSA’s support of the wider church I have continued to supervise Tom Dunbar who will be ordained this spring at the Annual Meeting of London Conference. I have also been on Brad Johnson’s discernment committee as he looks toward ordination. This last six months has been an exciting time in my ministry and I look forward to serving the congregation for another six months as you complete the JNAC report and the search process for permanent staff.

BOARD OF TRUSTEES - CHAIR'S REPORT

Your Board of Trustees met officially on February 7th, May 9th, September 12th and November 7th of 2011.

Trustees include: John Eberhard (Co-Chair), David Manness (Co-Chair and Investment Committee Chair), Russ Gonder (Insurance Committee Chair), Stan Hill (Long Term Giving Committee Chair), June McKay (Memorials Committee Co-Chair), Russ Monteith, Bill Peel, Robin Procnier, Bob Schram, Bob Slater (Memorials Committee Co-Chair), Katherine Wonfor (Secretary). Also attending Trustee meetings on regular invitation are: Kate Crawford (Minister of Worship and Administration), Harold Jackson (Chair of Finance) and Russ Scorgie (Representative of Property). The Board of Trustees holds and administers all property owned by the Church for the benefit and use of the First-St. Andrew's United Church Congregation as part of The United Church of Canada under the provisions of the *Trusts of Model Deed* of the United Church Manual. The Board holds the freehold title to the lands upon which the church sits.

The Board of Trustees has four committees accountable to it. At least one member of the Board serves on each committee. The committees are as follows:

- a) Investment
- b) Insurance
- c) Long-term giving
- d) Memorials

The Board of Trustees began 2011 with assets under management evaluated at \$1,791,446. These net assets consisted of the CAPITAL FUND (\$1,170,693) and RESTRICTED FUNDS (\$617,455), made up of the Clark Fund and the Wm. & J. Brown Fund.

In 2011, at the direction of the Congregation and Council, your Board of Trustees transferred \$ 40,000 from the CAPITAL FUND to Council. This \$40,000 transfer, in total, has been placed in the Capital Reserve Fund of Council.

At December 31st, 2011 the CAPITAL FUND is now valued at \$1,277,796 and the Restricted Funds are valued at \$640,496. The Capital Fund is the benchmark used for the "CAP FORMULA" which represents the amount of money our Congregation agreed should be sustained at all times in the Capital Fund. With a "CAP" of \$1,277,196.00 for 2011, this leaves the Trust Accounts "over funded" by \$600 at year end 2011. This is a great improvement from being under funded as of December 2010 by \$224,899, mainly thanks to receipts of bequests received in 2011 (as shown immediately following) and thanks to the sound financial management by all committees of the church, with leadership from the Finance Committee.

On behalf of the congregation, the Trustees have gratefully acknowledged bequests that were received in 2011. These are vital to the overall financial health of our wonderful church. They have been invested and will be put to good use in future in capital building projects. These significant bequests have come from the estates of Margaret Leonard (\$50,000), Ron Logan (\$50,000) and Lillian Hodgert (\$35,000) Because of the improved stability of the Capital Fund, the Trustees with the approval of Council announced a matching grant program for the Capital Building Fund (for the next phase of the Avis project) to a maximum of \$75,000.00 in 2012.

Choosing to leave a legacy from the heart to your church can insure special meaning, worth and purpose to a life well lived. Your generosity through your will can ensure your values and commitment to FSA continue. This practical addition to a financial or estate plan can be a most satisfying accomplishment in a person's life.

Your Trustees continue to support the good work of the Finance Committee for adhering to a better than “balanced budget” in 2011. And we continue to recommend that the Income of the CAPITAL FUND should be spent on capital items. The Board of Trustees cautions Council to ensure that Trust funds are not depleted on operational items so as to provide for the long term financial health and sustainability of our assets.

Your Board of Trustees are pleased with accomplishments of 2011 and will be busy in 2012 looking after our fiduciary responsibilities. We are pleased to include copies of the trust statements (included with the Financial Statements) with this report.

1. **BOARD OF TRUSTEES**

These financial statements report the activities of the investments empowered to the Board of Trustees of First-St. Andrew's United Church. They do not report the assets or activities related to the operations and administration of the Church.

2. **BASIS OF PRESENTATION**

The financial statements are presented on a fund basis. The revenue, expenditures & activities of the funds are reported directly within each fund. The funds are restricted to their intended use as described below:

Capital Fund

To be used for capital expenditures and to operate the general activities of the Board of Trustees.

Restricted Funds

Clark Fund

To provide support for continuing education.

Wm & J Brown Fund – Youth

To support the activities of the Youth of First-St. Andrew's United Church.

C. Wilson Fund

To provide support to organ apprentice music programs.

3. **SIGNIFICANT ACCOUNTING POLICIES**

Financial Instruments

The Board of Trustees' financial instruments consist of cash, hst receivable, investments, accrued liabilities and due to council. It is the Trustees' opinion that the Board of Trustees is not exposed to significant interest, currency or credit risks arising from these financial instruments. The measurement and carrying value of these financial instruments is market value.

Investments

The Board of Trustees investments are classified as held for trading and are carried at market value. These investments include amounts in Bonds, Notes, Guaranteed Investment Certificates, Equity Stocks, Mutual Funds and Preferred Stocks.

Revenue Recognition

Revenue is recognized in the period to which it relates on an accrual basis.

Interest on bond coupons is amortized on a straight line basis over the term of the bond.

Increases (decreases) in the market value of investments are recognized in the year.

Capital Expenditures

Costs with respect to capital expenditures are expensed in the year incurred. There were none in 2011.

Use of Estimates

The preparation of the financial statements that are in accordance with Canadian generally accepted accounting principles requires the Board of Trustees to make estimates and assumptions that are based on currently available information. Such estimates and assumptions may affect the reported amounts of assets, liabilities and fund balances as at the reporting date, and the reported amounts of revenue and expenditures during the fiscal period. Actual results could differ from the estimates and the assumptions used.

4. **RELATED PARTY TRANSACTIONS**

Due to Council represents amounts owing to First-St. Andrew's United Church from Wm & J. Brown Fund Youth (\$11,834) and from the Capital Fund (\$3,934).

Transfers to Council represent amounts paid or payable to First-St. Andrew's United Church, pursuant to any direction lawfully given by Council and/or the Congregation.

Transfers from Council represent amounts received or receivable from First-St. Andrew's United Church, pursuant to any direction lawfully given by Council and/or the Congregation.

This fall there has been on average 4 children in the nursery but the numbers seem to be increasing in recent weeks.

Church School

The FSA Church School enjoyed a renewal of sorts in 2011 as a number of children who had been with us since they were 3 and 4 years old have moved up into Teens in Transit and the God Squad (though they lovingly and faithfully return to help us out!). New furniture, including soft chairs and tables for constructing and rigid tables and chairs for classes, has been acquired and is already being enjoyed. The children and supporters of the church school held another delightful Big Circle breakfast in support of Mission and Service work internationally on Palm Sunday. In June, children young and old romped outside in the 2011 Spirit Games and came away rather wet, happy, and tired! Our newest church school members arrived this fall and the community has opened its arms to welcome and induct them into our programming. The children have just completed their hard work and good spirits in the Christmas pageant, which proved both funny and touching. We continue to be blessed with outstanding parent and supporter volunteers who teach and facilitate to make all of our children feel welcome. We look forward to a great year with all of FSA's distinct children in 2012!

TNT

The youth of grades 7 and 8 enjoyed an active year. We helped with ushering, greeting, lighting the Christ candle, reading the scripture, church school, nursery and Spirit Games, rummage and antique sales, yard cleanup, and coffee and conversation. Several members are part of the Joyful Singers, young soloists at Advent Noon Recitals, and acting parts in the Christmas Eve Children's Pageant. We had fun at some movie nights with God Squad, and skating at Victoria Park as well. Perhaps the highlights for the year were the making of a video for Susan Shelstad's farewell dinner and preparing a youth lead worship service for the congregation.

In the early part of the year there was a core group of four young ladies. You continue to be encouraged to make FSA your favourite charity in 2012, if this is not already the case. Your support and generosity is essential to this great Congregation continuing to deliver its promise of being “**At the Heart.**” The plan to be operationally deficit free in 2011, will again be realized. Our 2012 financial position will be enhanced with the surplus from 2011 operations being used to augment the capital reserve fund, while maintaining a healthy operating fund to meet the variability of income and expense on a monthly basis. There were paid staff complement challenges in 2011 that required us to ask more of them this year and they responded. To them we must pay particular recognition. We are truly blessed by their

talents and dedication to the mission and vision of our Congregation. Importantly, we must continue to operate with a balanced budget. To that end, the 2012 budget forecast has been prepared with this objective in place. We appreciate the support and cooperation received from all Committees that has led to being able to present again a balanced budget forecast for 2012.

We are indeed fortunate to have a well-qualified and dedicated Finance Committee. In 2011 we welcomed Doug Jones as a new member of the Finance Committee. Other members are: Michael Bancroft, Kate Crawford (Minister of Worship & Administration), Dennis Dalton, Carol Foley, Harold Jackson (Chair), Debra Low (Church Administrator), Don Reid and Donna Travis. This year, as a result of retirement, we said good-bye to Susan Scorgie. We acknowledge her over 10 years support to the financial and other administrative roles facilitated on behalf of the congregation. The valuable support provided by her to this Committee, in particular, is gratefully recognized. Our collective thanks Sue and wish for a happy retirement! We were privileged to welcome Debra Low in September as the new Church Administrator. Her accumulated training and work expertise make for an excellent addition. We look forward to her financial management contributions, as she gains familiarity with church systems and congregation.

REVIEW ENGAGEMENT REPORT

TO THE MEMBERS OF FIRST-ST. ANDREW'S UNITED CHURCH

I have reviewed the statement of financial position of First-St. Andrew's United Church as at December 31, 2011 and the statements of operations and changes in fund balances and cash flows for the year then ended. My review was made in accordance with Canadian generally accepted standards for review engagements and accordingly consisted primarily of enquiry, analytical procedures and discussion related to information supplied to me by management.

A review does not constitute an audit and consequently I do not express an audit opinion on these financial statements.

Note 3 to the financial statements indicates that capital assets, including land and buildings, have been recorded at a nominal value of \$1 and that the purchase of capital assets are expensed in the year of acquisition. Canadian generally accepted accounting principles require not-for-profit organizations with revenue greater than \$500,000 to capitalize and amortize capital assets. The effects of this departure from Canadian generally accepted accounting principles on the unaudited financial statements have not been determined.

Except for the policy as described in the preceding paragraph, not to record and amortize capital assets, based on my review, nothing has come to my attention that causes me to believe that these financial statements are not, in all material respects, in accordance with Canadian generally accepted accounting principles.

4. FINANCIAL STATEMENTS

These financial statements report the activities related to the operations and administration of the Church. They do not report the assets or activities of the Board of Trustees or the UCW.

5. BASIS OF PRESENTATION

The financial statements are presented on a fund basis. The income, expenses and activities of the funds are reported directly within each fund. The funds are restricted to their intended use as described below:

Operating Fund

To be used to operate the general activities and administration of the Church.

Restricted Funds

Music Funds – Administered by the Director of Music

Bray Fund

To provide support for undesignated music programs.

Cram/King Fund

To provide support to Children's music programs.

Eberhard Scholarship Trust Funds

To provide support to vocal music scholarship programs. The Principal Fund must be retained while the Interest Fund may be spent.

Inch/Petts Fund

To provide support for undesignated music programs.

C. Wilson Trust Funds

To provide support to organ apprentice music programs.

Friends of Music Fund

To provide support for special music concerts and events.

Wm. & I. McKane Bursary Fund

To provide financial assistance in the form of bursaries to musicians.

Other Restricted Funds

Discretionary Fund

To provide funding for non budgeted expenditures as directed by the honourees.

Benevolent Fund

To provide support for discretionary benevolent purposes. Administered by Ministerial staff.

2. BASIS OF PRESENTATION (continued)

Clark Fund – Interest

To provide support for continuing education. The principal of the Fund is maintained by the Trustees and interest is transferred to the Church to provide income for the Fund. Administered by the Ministry & Personnel Committee.

Hospitality Meals Fund

To support the weekly hospitality meal program under the direction of the Mission, Outreach & Environment Committee.

Capital Building Fund

To be used for infrastructure renewal as outlined in the Avis Report under the direction of Council.

Capital Reserve Fund

To be used for capital expenditures under the direction of Council.

3. SIGNIFICANT ACCOUNTING POLICIES

Financial Instruments

The financial instruments of the Church consist of cash, guaranteed investment certificates, amounts receivable and accounts payable and accrued liabilities. It is Council's opinion that the Church is not exposed to significant interest, currency or credit risks arising from these financial instruments. The measurement and carrying value of these financial instruments is market value.

Revenue Recognition

Revenue is recorded in the period to which it relates on an accrual basis.

Capital Assets

Capital assets consisting of land, buildings, furniture and equipment have been recorded at a nominal value of \$1. Current purchases of capital assets including renovations are expensed in the year of acquisition through the Capital Campaign and Capital Reserve Funds.

Contributed Services

The Church is dependent upon the many hours of volunteer work contributed by its members, the fair value of which cannot be estimated. Contributed services are not recognized in these financial statements.

Use of Estimates

The preparation of the financial statements that are in accordance with Canadian generally accepted accounting principles requires Council to make estimates and assumptions that are based on currently available information. Such estimates and assumptions may affect the reported amounts of assets, liabilities and fund balances as at the reporting date, and the reported amounts of revenue and expenditures during the fiscal period. Actual results could differ from the estimates and the assumptions used.

Sub-Committees

Congregational Visiting Team

The White Squirrel Golf Tournament provided additional funds for this extensive program. Gifts were donated and wrapped for their Christmas Hamper program for families.

Amnesty International:

A Write- a- thon was held in March 2011
124 Messages of Hope were signed during Advent

Grow-A-Row and Corn Roast:

These fundraisers for the Canadian Foodgrains Bank raised \$6253.63 at FSA this year. With the addition of the profit from the crop at the McLarty Farm of \$3470.00, and the donations from St. Mary's United Church, the total came to \$16,225.00. These funds are matched 4:1 by the Canadian International Development Agency (CIDA).

This joint project organized by Jean and Bill Knowles and David Knoppert began in 1995.

Comfort Quilts:

More quilts were made and sent to Canadian soldiers injured in Afghanistan but this program has now ended.

In the future, quilts will be sent to "Project Linus" which collects quilts and donates them to local children in need of comfort.

Los Quinchos School

Fair Trade, organic coffee and chocolate have continued to be sold to raise funds for this school for street children in Managua Nicaragua.

Green FSA:

In January a "walk through" of the church was made to assess possible energy savings.

At Supper Club in February a presentation was made by a couple who had built an environmentally sustainable home.

Environmental Sunday-Committee members participated in the service and a satirical dramatization of a conversation between Rev. Dr. Kate Crawford and "God" on lawn care was presented!

NOMINATING COMMITTEE

The Nominating Committee had a busy year in 2011 with the retirement of Rev. Dr. Susan Shelstad and the subsequent need to form a new Joint Needs Assessment Committee, and the Provincial requirement to form a new Accessibility Committee to address the Changes to the Ontario Disability Act. This was in addition to filling several vacancies on Committees and bringing the Committee Membership list up-to-date. Regarding this latter aim, the current policy states that the Term of Office for regular Committee members is three years and committee members may only be renewed twice, so the maximum time a member can serve on a committee is nine years. The Nominating Committee recommended to Council at their December 2011 meeting that the requirement for a maximum of three Terms of Office for members of Committees be removed. The motion notes that the removal of set terms does not apply to Committee Chairs, who retain the current terms of office, or to the Board of Trustees who have their own terms of office, as do the Presbytery Representatives. This motion was approved by Council and the following motion therefore will be added to the Agenda of the AGM to be voted on by the congregation:

MOTION: moved that the requirement for a maximum of three Terms of Office for regular FSA committee members be removed and the wording in the Statement of Policies and Procedures in Sections 3.2.7, and any other references to these terms be changed accordingly. The change in wording in Section 3.2.7 will be changed from:

“It is recommended that no member of the congregation serve on any one committee for more than three consecutive terms. However, where there will be more than a 60% turnover of membership on any committee and in the opinion of the Nominating Committee an unacceptable impairment of the operation of the committee would thereby result, the congregation on the recommendation of the Nominating Committee may extend for a further term or terms on a committee of a person whose term would otherwise extend beyond the three term recommendation.”

To

“Regular committee members may extend their three year terms indefinitely if they so desire and if this is sanctioned by the Chair of their Committee. This does not apply to members of the Board of Trustees, Presbytery Representatives, or Church Officers, all of whom have their own Terms of Office. The summary of all Terms of Office is listed in Appendix A of the Statement of Policies and Procedures for First-St. Andrew’s United Church.

The Nominating Committee would like to thank all the people who volunteer so willingly to serve on our Committees, and to thank the members of the Accessibility Committee (Cherry Bulmer, George Jolink, and Chantal Laprise, Pat MacGregor, Aldis Murray, Ken Wright), and the members of the Joint Needs Assessment Committee (Chair: Jean Wuensch, Secretary: Ann MacPhail, Jacob Feeney, Bev Lindsay, Jean Wright, and Paul Pergau). PROPERTY COMMITTEE

The committee is responsible for the physical property of the church, including operation and maintenance, repairs, new projects and planning.

Our Physical Assets

FSA is blessed with beautiful historic buildings and grounds in a key downtown location. The age, size and condition of our building present many challenges. In recent years, the most significant challenge has been the lack of funding available for capital improvements and major repairs.

Building Condition Challenge

The Building Condition Assessment Report (Avis Report), completed in 2008, identified elements which require attention over the next 10 years. The Save Our Sanctuary (S.O.S.) capital campaign raised approximately \$100,000 that was used in 2011 to repair the most urgent masonry repairs - mostly at the higher levels. With the continued financial support from the congregation, it is hoped that we can finish the masonry work and renovate the front entry in 2012. It will take a number of years and a considerable funding commitment to complete this work which will eventually include a new heating system and replacing the slate roof.

Other Capital Projects

The items identified in the Avis Report do not include other capital projects and major maintenance needs. For many years, these needs have been funded substantially from the Capital Reserve, money generated by the church's trust funds. Some projects, like exterior painting need to be completed on a regular basis.

A number of smaller projects are often handled by the Custodian and/or volunteers, including plaster repairs and interior painting. We are grateful as well to the UCW who funded the installation of a set of handrails to assist in accessing the chancel. One of the larger projects that is expected to be completed in 2012 is a revamp of the sound system and the flat roof over St. Andrew's Hall which as caused some leakage in the past year. We are also investigating how we can better meet the needs of those in the congregation with accessibility issues by designating handicapped seating locations and the replacement of the loose chairs with something more permanent.

Building Operations

The committee's operational budget is substantially devoted to non-discretionary operational and maintenance expenses such as security, elevator and grounds maintenance. Minor repairs such as drainage issues, heating system repairs and lighting are also covered by this budget.

Building Rentals

The rental policy implemented a couple of years ago continues to be fine-tuned with the result that costs for funerals have been streamlined and the contract with Kiwanis has been brought in line with the policy. Most users have come to understand and accept the new reality. There have been few real complaints. Overall, the policy has been a great success. Revenue is up substantially and this is significant to the church budget. In 2012 we will be focusing on our parking rentals to ensure they are close to market rates.

Fund Raising

The committee continues to run the flower sale. This year, Council agreed to rename the sale to the Marg Leonard Plant Sale.

Volunteers

Volunteers continue to be very important to the ability of the church to maintain its property and keep it beautiful at modest cost. Their efforts are evident in the spring and fall clean-ups, grass cutting and trimming, trimming of shrubs and trees, planting and maintenance of flower beds, painting and repairs, and fund raising activities. We would like to thank all those who assisted. Some contributed enormous time and effort. Special thanks to Bev MacDonald for the endless hours he has dedicated to FSA.

Staff

A special thanks to staff for their efforts on behalf of the congregation and the Committee:

Geoff Bottomley has done an excellent job maintaining our facilities. He also initiates and completes many small projects. Geoff is assisted in his custodial activities by Valerie de Jong.

Paul Merritt has undertaken a significant and important new duty, managing the Space Rental arrangements in conjunction with Paul Mansell.

We much appreciate the complete and accurate financial statements and budget information provided by Sue Scorgie until her retirement, and now Debra Low. We thank her also for getting out those invoices, so essential to the rental income reality.

Thanks also to Maureen Scarborough for keeping the calendar of events, including rentals, up-to-date and other general assistance.

STEWARDSHIP COMMITTEE

At the first Stewardship Committee meeting in March 2011 we reviewed the Terms of Reference ‘to educate the congregation of First-St. Andrew’s United Church (FSA) with regard to the ongoing need to financially support the ministry, life and work of FSA through regular (weekly, monthly) giving, fundraising, special projects, etc.’ We agreed that our work would also be shaped by FSA’s mission as ‘an inclusive Christian Family encouraging spiritual growth through worship, friendship, learning and action.’

Assisting in the process for 2011 were Harold Jackson, David Manness (alternate Robin Proconier) , Debbie Schram, Katherine Wonfor, Judith Walker (Chair) and Dr. Kate Crawford. We were pleased to welcome George Jolink to the committee in November.

We have worked to change the view of Stewardship from a once a year financial pledge campaign to one where every member would be engaged in understanding their personal responsibility as a steward of God’s many gifts to us with accountability to one another and to our faith. Each year we acknowledge this responsibility through our financial support for the Annual Pledge Campaign. Materials from the United Church of Canada were beneficial to the committee in planning the road to the future.

We reviewed the sources of revenue that benefit the life and work of FSA and discussed how we might present this information to the congregation with a view to building greater understanding of how their gifts are invested. As a result a document entitled *The Narrative Budget* was designed by Harold Jackson, Debbie Schram and David Manness. This information will be distributed at a later date.

We identified as a major challenge the lack of a strategy that will attract new members, of all ages.

There was lengthy analysis of the Capital Campaign launched under the leadership of Debbie Schram. With her assistance, the decision was made to redesign the program and add a Capital Building Fund request to the annual pledge campaign launched in October. We are grateful to the Board of Trustees for their support in introducing a ‘matching gift’ concept. For 2012 gifts to the Capital Building Fund will be matched dollar for dollar from unrestricted Trust Fund income to a maximum of \$75,000.

The Annual Pledge Campaign was launched on Thanksgiving weekend. For the next six weeks a member of the congregation reminded us of the value of our financial stewardship in “**Sustaining the Heartbeat**” of FSA. The outcome of the Annual Pledge Campaign will be reported by the Finance Committee.

I would like to thank Sue Scorgie, Debra Low and Katherine Wonfor for their assistance in developing a database program that will support the growth of Stewardship at FSA.

On behalf of the Stewardship Committee I would like to thank each of you for the generous support that you provide to FSA each day as leaders, teachers, community volunteers, donors and as friends.
