6.0 Committee Reports

6.1 Christian Development – Allyson Watson

Written report circulated.

- The Camp Kee Mo Kee weekend will be held on June 2 to 4. A potluck lunch will be served and committees were asked to help provide the food.
- The Lenten project proceeds will go towards the Heritage Week at Camp Kee Mo Kee. To date \$1,000 dollars has been raised.

6.2 Communications and Marketing – Jim Silcox

Written report circulated.

The Communications and Marketing Committee has discussed the number of events and fundraisers being hosted by various committees. While the work of the committees with regards to outreach is commendable, Communications and Marketing feels that FSA is approaching donor fatigue and that events are possibly competing for patrons.

Council agreed that the church calendar of events is very full and that the timing of proposed events and fundraisers should be looked by a committee to ensure that events are not competing and are successful.

6.3 Finance – Mike Bancroft, Dale Pettit

The proposed 2017 Budget was circulated.

- the deficit before support from the trust funds and UCW is \$161.483
- trust fund and UCW support is budgeted at \$145,000
- the deficit could further be reduced by approximately \$20,000 if the position of Visitation Minister is not filled after the Rev. Tom Hiscock's retirement in May 2017
- Council considered whether the decision regarding the continuation of the Visitation
 Minister position should be brought to the congregation. It was suggested that
 options be presented to the congregation with the financial implications made known
 so the congregation can make an educated decision. Council requested that
 representatives from Membership and Nurture and Ministry and Personnel meet to
 discuss options and bring forward recommendations to the May meeting of Council.

Statement of Revenue and Expenses at January 31, 2017 was circulated.

- at January 31st there was a surplus of \$13,120
- revenues were under budget by \$1,545
- expenses were under budget by \$10,282
- support from the UCW of \$6,500 was received in January

Statement of Revenue and Expenses at February 28, 2017 was circulated.

- at February 28th there was a deficit of \$12,304
- revenues were under budget by \$8,373
- expenses were over budget by \$3,988
- February expenses included furniture and equipment for the office of the Church Administrator (\$2,818) and consulting fees for Drake Personnel (\$1,500)

8.2 General Council Remits - Michelle Down

Council voted on the remits from the 42nd General Council.

Remit 1 - Three Council Model

Does the pastoral charge agree that:

- (a) the United Church be re-organized in the three-council model approved by the 42nd General Council 2015; and that
- (b) the Basis of Union be amended to reflect this change?

Yes: 12 No: 0

Remit 2 -- Elimination of Transfer and Settlement

Does the pastoral charge agree that:

- (a) the processes of transfer and settlement for members of the order of ministry within the United Church be eliminated, including the elimination of the General Council Transfer Committee; and that
- (b) the Basis of Union be amended to reflect this change?

Yes: 10 No: 1 Abstained: 1

Remit 3 - Office of Vocation

Does the pastoral charge agree that:

- (a) a denominational office of vocation be established in the structure of the United Church, with responsibilities and structure as approved by the 42nd General Council 2015; and that
- (b) the Basis of Union be amended to reflect this change?

Yes: 8 No: 4

Remit 4 -- Funding a New Model

Does the pastoral charge agree to a new funding model for the United Church with the budgeting process guided by the following principles?

- (1) use Mission and Service to fund ministry and mission activities;
- (2) fund governance and support services of other courts/councils by assessing communities of faith/pastoral charges;
- (3) share assessments equitably across the whole church;
- (4) permit conferences/presbyteries/regional councils to use additional resources for regional purposes; and
- (5) encourage sharing of all resources across the church.

Yes: 6 No: 6

First-St. Andrew's United Church Minutes of Council April 18, 2017 Remit 5 -- Ministry Partners will be voted on by presbyteries. Pastoral charge approval is not required.

Remit 6 -- One Order of Ministry

Does the pastoral charge agree that there should be one new order of ministry encompassing the present categories of recognized designated lay ministers, diaconal ministers, and ordained ministers, with ordination to the ministry of word, sacrament, education, service and pastoral care as the single rite of entry, and with provision for the continued identity of the diakonia within the ordained ministry?

Yes: 6 No: 5 Abstained: 1

The completed ballots for the remits will be sent to the General Council Office.

8.3 Seating at church events where food is served

MOTION: For each church sponsored event where food is served, two positions along the long side of a table should be reserved for wheelchair seating.

MOVED: By Jim Silcox, seconded by Allyson Watson. MOTION CARRIED.
