# **6.1 Christian Development** – Allyson Watson

### 6.3 Finance - Harold Jackson

Financial reports at January 31, 2016 were circulated.

Upgrades are required for the audio controls software and gooseneck microphones used in the sanctuary.

MOTION: That Capital Requisition 2016-001 regarding the sound system upgrade at an estimated cost of \$3,100 be approved.

MOVED: By Harold Jackson, seconded by John Eberhard. Motion carried.

The sanctuary lighting dimmer system was damaged by an electrical storm and due to its age replacement parts are unavailable. A proposed new dimmer system will be compatible with LED lights.

MOTION: That Capital Requisition 2016-002 regarding a new dimmer board which is LED compatible at an estimated cost of \$26,000 be approved.

In preparation for the Annual Meeting a Narrative Budget for 2016 was circulated. The Finance Committee requested that if the budget is defeated at the Annual Meeting the budget be sent back to Finance for revision with the recommendations received from the congregation. A meeting of the congregation would then be called to approve the revised budget.

### 6.4 Membership and Nurture – Audrey Coulthard

- Renewals and new subscribers for The Observer are being managed by Audrey. Envelopes have been placed in the mail boxes.
- The Membership Roll is being updated. All members and adherents of the congregation are encouraged to fill out and submit the form.

### **6.5 Ministry and Personnel** – Bruce Moor

Bruce reported on the February 7 consultation with the congregation regarding the position of Director of Music.

- 100 people attended and provided input for the future of the music program
- the position of Director of Music is an important leadership role, music is a fundamental plank of FSA
- from congregational input received it is recommended that the position continue as full time in order to attract a qualified candidate and continue the breadth of programming offered

- It was suggested that under qualifications "Familiarity with a tracker action, three manual, pipe organ is essential." Be revised to read "*Professional* familiarity with a tracker action, three manual, pipe organ is essential."
- Recommendations from the Royal Canadian College of Organists will be used when setting the salary.

MOTION: To approve the position description for the Director of Music with the above revision

MOTION: To advertise the position of Director of Music as full time.

DISCUSSION: Budget concerns need to be considered before the job is offered to a candidate.
