Laura Wood, Treasurer and Chair of Finance, presented the 2024 budget. Two townhalls were held to present the budget and discuss FSA's financial position.

For 2024, revenue of \$487,000 and expenses of \$680,000 are forecasted. The trust funds will cover \$100,000 of the deficit. The Finance Committee is actively working to address the forecasted deficit of \$93,000. The position of Facilities Manager is vacant, and hiring has been deferred for six months with volunteers from the Property Committee and the congregation filling the job.

David Wardlaw reported that recognizing the barriers to home ownership foreign nationals face (The Prohibition on the Purchase of Residential Property by Non-Canadians Act) a Housing Task Force was formed to look at solutions for how FSA could assist the Lawrence family. A recommendation was brought to the Board of Trustees and Council that FSA purchase a house and lease it to Joshua Lawrence. The lease payments are at market value and there is an option to purchase the property when the Lawrences become permanent residents of Canada. The agreement was vetted by a lawyer. Approval was received from the Antler River Watershed Regional Council who thought this was an innovative and positive way to support our minister.

The congregation expressed their agreement with this housing solution.

# 9.4 Report on Council approved process leading to replacement of existing heating system – George Jolink, Steve Elson

Steve Elson reported that while the boiler remains operational it is becoming increasingly unreliable. A task group will be formed to consider options for a new HVAC system.



# FROM THE MINISTER OF WORSHIP & CON-GREGATIONAL LIFE

#### SANCTUARY AND THE SUBLIME

t was difficult this morning, and not simply because of the snow which had yet to be shoveled. Well, maybe difficult isn't quite the word. Heavy is perhaps more accurate, more precise in its brief diagnosis of life for many of us. I felt the weight of the day, the weight of the year. Already. So many changes, so many uncertainties. Whither are we moving? How long must we wait? Has the Christ-child actually arrived in our time and place?

Not that I want to overdetermine your experience of this "new" year, but I suspect some if not all of these questions have passed through your mind in recent weeks. And if you are anything like me, your responses have been a rotation of immediate tasks and enjoyable distractions. Nothing wrong with either, but I do believe something different is warranted. Something like listening, but not in the typical way that we listen for "keywords," or wait for a pause so we can intervene with our brilliance. No, the listening I have in mind now is the kind of listening that can take weeks and months—sometimes years. Resisting the temptation to volunteer quick solutions to deeply embedded (structural, systemic) problems is necessary if we are find a way forward—as a community of faithful practice, as a city, and as a country. So listen we shall. But where and how?

I want to propose that we revisit the idea and practice of sanctuary. Sure, the word is used quite often, especially by members of First-St. Andrew's. But in most cases, it refers to a physical space where we celebrate, worship, and have concerts. I intend something beyond this usage,

though not wholly unrelated. Some will be familiar with the Greek term "liturgy," from leitos (public) and ergos (work). And historically, the Church has understood liturgy (the structure of worship) as the "work of the people." Some might say that this work refers to a kind of praise structure. where hymns and acknowledgment of God are primary. But I would suggest, to the contrary, that while these aspects are certainly present in most liturgies, they are not the most important part of a liturgy. And I don't think anyone at First-St. Andrew's believes that God needs weekly cheerleading to "perform." Therefore, I want to propose instead that liturgy is the activity of building/cultivating the beloved community through activities like prayer, song, reflection, and many other forms of creative engagement with Holy Mystery. After all, the Gospel of Matthew has the figure of Jesus make clear that loving God and loving neighbor are inextricable (22: 36-39). On these hang the Law and the Prophets. The Apostle Paul echoes this emphasis in his famous meditation on love in 1 Corinthians 13. And if this unconditional, encircling love is the greatest commandment, then what else should receive the most attention in our work as people of faith and practice.

We can now freshly examine the idea of sanctuary. If sanctuary is etymologically designated as a "holy space," what better way to cultivate and practice holiness than by extending welcome and compassionate care to all people. We might say that there are degrees of holiness insofar as not all holy spaces are as welcoming. I and many others have learned this the hard way, having been met with summative dismissals if not outright discrimination because of the beings we are. However, we at FSA are committed to being an Affirming community. We are also a gathered body that works towards Truth and Reconciliation. And for those of us who benefit or have benefited from white supremacist structures

of power and plunder, we are a people committed to practicing Anti-Racism in our daily lives. There are many ways that we must grow in each of these areas of our life as faithful practitioners. And in doing so, I believe we are certainly living sanctuaries, emancipatory spacemakers.

Having probed the possibilities of true sanctuary for our present, and I hope being stirred in the direction of extravagant welcome, we must also look into the future with humility. This is where we encounter the sublime. For those unfamiliar with the term, it stems from artistic and philosophical discourse of the 18th and 19th centuries. The sublime refers to an experience that the mind cannot exhaustively categorize or contain. It is too vast, too mercurial, for our disposition to comprehension and management. We often hear of the sublime in art and music, but I would extend this experience to all of life. How many times have we been surprised and brought to tears by the simplest gesture, a smile or handshake, a falling leaf, a line of poetry? These priceless and unpredictable experiences of resonance, wherein we are addressed by this majestic world we get the privilege of inhabiting. But lest I only emphasize the gentle aspects of the sublime, we are also frequently confronted by it in the face of a winter storm, a terrible loss, or a definitive crisis of faith. These experiences too can be thought of as sublime. Like all religious experience and practice, the sublime is a contested space. There is nothing beyond life itself that will teach us what we are to receive from these sublime experiences. Nor can we manufacture the beautiful and terrible moments that arguably constitute the essence of abundant life. But we must always heed them and come to realize that they are what we crave, what we need, and why we practice sanctuary. So that all might feel nurtured, supported, and connected, not only to community but also to

that experience of the Sublime/Divine/Holy that abides with us as humans.

And we should be humbled by the awareness that these encounters/experiences are often threatened by our efforts to control/manage/categorize. Both sanctuary and the sublime refer to organic practices of care, attention, and presence that can only be leaned into with trust, hope, and love. The more we try to determine them, the less likely they are to emerge in our life together.

Having come full circle, we should all be delighted in much of what transpired at FSA in 2024. New members, new programs, new opportunities to serve and create. New ways to grow and contribute not only to our community but to an ever-widening, diversifying network of relations. And we should all be humbled by the opportunity to trust just a bit more in 2025. To be still long enough to listen, to hear, and eventually to respond. As tempting as it might be to act and plan. I want to encourage us all to rest in the assurance that the efforts we have made to be abundantly hospitable have borne fruit and continue to bear fruit beyond what we can know. And just as so much that occurred in 2024 happened outside of our expectations and plans, so too will 2025 have surprises, sometimes pleasant and sometimes completely disruptive. What we can do, gently and humbly, is become vibrant sanctuaries ourselves and remain open to the great swirls of cosmic unfolding that have brought us to this place and time for tasks which we are still discerning together. Weighty and difficult for sure. But also joyous and meaningful. May we all receive this upcoming year in the fullness with which it is given to be received. May we honor this life, our life, and the life of the world with our faithful practice.

#### FROM THE MINISTER OF PASTORAL CARE

t continues to be a joy and privilege to be in pastoral ministry at First-St. Andrew's. For 12 hours a week, I visit members in Long Term Care, Retirement Homes, hospitals, and homes. Contacts are also made by email and phone calls. I also attend the monthly church service at Richmond Woods with Joshua. Getting to know the life stories, struggles, and faith connections of the First-St. Andrew's congregation has been a blessing.

Working closely with the Minister and Chairs of Membership & Nurture, I identify the persons and families for whom support is needed; visit members who are experiencing a life transition, illness, grief, loneliness, stress, or family or personal crisis; and offer prayer, and pastoral/spiritual support. Empathy, active listening, meaning making, spiritual guidance, comfort, crisis interventions, and support, are the foundation of my interactions.

Virtually I attended the national Canadian Association for Spiritual Care (CASC) Conference held in London, ON from April 14-16, 2024. There were 2 Keynote Speakers. Shadrach kabango (Shad) – a black Kenyan born rapper and hip hop artist, and Juno award winner who grew up in London ON spoke of his faith journey, meaning making in music and art, the experience of new Canadians, the meaning of suffering, and spiritual inspiration. The second speaker, Rev. Dr. Carrie Doehring, Professor of Pastoral Care and Counselling at Iliff School of Theology is a psychologist whose most recent publications explore the moral stresses of religious leadership and chaplaincy, the moral stress of student debt, military moral injury, and assessing competency in intercultural and evidence-based spiritual care.

The Workshops I viewed were: "Spirituality, Meaning-Making & Reality – Helping Clients Make Sense of Spirituality, Life and Its' Events;" "What Modalities Do Spiritual Care Practitioners

Use When Offering Spiritually Integrated Psychotherapy?;" and "Early Exits: Spirituality, Mortality and Meaning in an Age of MaiD." I was grateful to be enriched by this Continuing Education opportunity.

I am thankful for the support of Rev. Joshua, the Membership & Nurture Committee, Margo Christodoulou from the Ministry & Personnel Committee, the FSA Staff, and many members of the church.

### FROM THE MINISTER OF MUSIC

y first full year as a part of the staff team here at FSA has passed.
Rather than dwell on highlights from our various events and programs, however, I feel it would be helpful to reflect instead on the "big picture" of music ministry in this time and place.

I do not need to remind you of the turbulent year that was. Our world and our city are both suffering from multiple crises, and in this environment, it can be exceedingly difficult to rise above feelings of helplessness and despair to keep fighting, to continue trying to make a difference, however small it may appear. And yet, resistance is not futile. (Sorry for the Star Trek reference!) We believe that we can make this world a better place by refusing to be governed by fear, to (in the words of composer, Mark A. Miller) "pray for your enemies, welcome the stranger, show love to your neighbour," as we sang in each of the Sundays of Advent 2024.

We are, I maintain, better placed for our mission when we are inspired with energy for the fight, and that is what I am coming to view as music's core purpose for our church family: to anchor ourselves in the eternal presence of the Holy, and to go out into our lives empowered to

follow Jesus; to care for all, not just for some, and to practise radical and extravagant hospitality, especially to those who do not look, sound, or act like us.

There is much still to do, but there is positivity in the air. New individuals and families of a variety of configurations are finding their way through our doors. The word is out in London and beyond that we have a kind of "secret sauce" and are forming an intentionally compassionate and affirming community of faith. People are finding something here, and hope - strange as it may seem in the global context of 2025 abounds. Our Senior Choir alone has added nine (!) new members since the start of 2024. Our Treblemakers, ReBELLS, and Ring of Fire groups for children and youth currently connect and support over thirty young people (and growing), most from beyond FSA. Individuals and families are experiencing the powerful difference that comes with not being alone, and this is so critical for folks to experience today.

The choir and guest musicians presented a concert in November, "Songs of Love and Remembrance," which included pieces by Jake Runestad, Eleanor Daley, Morten Lauridsen, and Gabriel Fauré that were filled with hope and the enduring comfort of the knowledge that there is, in the words of our New Creed, a "life beyond death." Such glorious music endures in our collective memory long past many spoken words, and this is a tremendous gift for us in uncertain times.

Recently, I stumbled across a song by a singer-songwriter named Ben Rector, and I hope these lyrics encourage you as we journey into the unknown together.

Please let me make something beautiful, a thing that reminds us (that) there's good in this world, a thing that reminds us (that) there's still something out there worth fighting for... Let it be something wonderful... Let it be something beautiful. Let us make something beautiful here in downtown London in 2025: a vibrant community of hope and refuge for all. May it be so!

# FROM THE CHILDREN AND YOUTH MINISTRY

he vitality of the FSA community is alive and strong as shown by increasing numbers in our children's programs. It seems we welcome new friends, families and young people weekly whether it be on Sunday mornings, for Joshua's C.R.E.W. or in Treblemakers/ReBells!

On Sunday mornings we have four classes weekly during our time together during church. We regularly have 15–22 kids ranging in ages from 1 – 17 years-old. In 2024 we used the curriculum *I am a Changemaker* which was encouraged by our region. This curriculum taught us to look at ourselves and how our behaviour can affect change in the world around us.

In 2024 we welcomed over 70 kids and young people on Sunday mornings. The congregation was generous by providing some additional stories and resources to add to our time together. This year we also met several new friends from our new Puppet Ministry: Oswald the Wise Owl, Pip, Tyrone, Dai and Meme who have helped us have some conversation about our questions about our faith.

Thank you to the many people who help us on Sunday mornings: Connor Campbell, Amanda Newbery, Linda Badke, Susan McKane, Lindsey Robinson, Christine Koustrup, Cara Bulmer, Steve Elson and Mary Ann Hodge. Thank you to Chad Louwerse, Leah Morise, Chris Wood, Linda

Imrie and Barrie Evans and David Wardlaw for bringing the puppets to life in such a heartwarming and entertaining way.

While the Youth Room is a happy place on Sunday mornings, it is also a place where young people gather in the afternoons. In 2024, 25 kids from four churches gathered for Joshua's C.R.E.W. This is a time for kids in grades 5–8 to gather to form friendships and have some fun together while we figure out the world around us. We have also welcomed Olivia Merryfield, who is a youth volunteer from a local highschool who is developing her leadership skills by coming out to get to know the kids.

Monday afternoons is when music and faith formation work together to host **Treblemakers** for kids ages 5–grade 8. In 2024, we had 45 kids enroll from 25 different families; 18 of those families were new to First-St. Andrew's. We gather to eat simple kid–friendly meals before heading up to the Sanctuary to make music together. In June we presented our musical, *Chilling in the Furnace* to the congregation with enormous success. It takes a lot of help to welcome this many kids and families on Mondays.

This past Fall, Laura Wood offered to add a drama component to our evenings for kids in grades 3–8. They are learning to express themselves through drama while managing to have some fun at the same time. We appreciate all the volunteers who help Treblemakers happen: Laura Wood, Pippa Belding, Alexis Cloutier, Jake Mendonca, Gillian Channer, Linda Imrie, Mary Ann Hodge, Susan and David McKane, Carol Elson and Ann MacPhail.

It has been such a busy and successful year, it seems like a long time ago that Marilyn Arthur moved on but somehow it has only been a couple months. Although the youth and young adults miss her greatly, Steve Elson and Mary Ann Hodge have done an amazing job at engaging highschool students on Sunday mornings while other programming and leadership is in limbo.

FSA has much to be excited about and look forward to in 2025!

# COMMITTEE REPORTS

## **COUNCIL**

n 2024 FSA continued on a path of positive transition, a journey that began in earnest in 2022, gained momentum in 2023, and further accelerated in 2024. The resiliency and vibrancy of the FSA community of faith is revealed in this Council report and in the numerous committee, group, and activity reports presented in this 2024 annual report.

A visible and uplifting sign of the vibrancy of our church is a growing number of adult, children, and youth participants: In new member services held in spring and fall, a total of 18 new adult and youth members were welcomed, this adding to the 20 new members welcomed in 2023. From January to December, approximately 105 (versus ~60 in 2023) different children and youth participated in FSA weekly and special programming (this includes Sunday School, Treblemakers, ReBELLS, and Joshua's C.R.E.W.).

Another sign of vibrancy is a complete professional staff complement for most of 2024. This is something that is difficult to achieve and challenging to maintain in a church for a variety of reasons. All of us should rejoice in this beneficial situation and take every opportunity to support our staff in their endeavours on our behalf. We are blessed with an outstanding leadership team which is making a positive difference!

The reader will have noticed the phrase 'most of 2024'. This is attributable to the departure of our shared Minister for Youth & Young Adults, Marilyn Arthur, in October of 2024. Marilyn became a diaconal minister in the spring of 2024 and accepted a call to be the Congregational Minister at Grace United Church in Tavistock in October 2024. Council is grateful for Marilyn's inspiring presence at FSA and for the dedication

and enthusiasm she brought to the shared ministry for youth and young adults. We offer best wishes to Marilyn in her new role. Grace UC has made an excellent choice.

### Future of Ministry to Children and Youth

Given the increase in the number of children and youth participating in FSA activities and programs in 2024 and the recent departure of our Minister for Youth & Young Adults there is now a substantial gap in staffing resources in this area. Faith Formation has undertaken a needs assessment to ascertain the level of staff time required to continue our current youth and young adult programming. With the needs assessment in hand and factoring in ongoing expansion in numbers and activities in children & youth area as well as synergies with FSA's other ministries, a small working group is preparing a proposal for consideration first by Faith Formation and then by Council in early 2025.

# Creating a Sustainable Operating Budget

The budget presentations at the congregational meetings in January 2023 and January 2024 made clear that we must focus more attention on stewardship, fundraising, sustainable revenue generation, and cost savings. A multipoint, multi-year plan to create a sustainable operating budget for the FSA community of faith was approved by Council in the spring of 2023. Implementation began in September 2023 and is ongoing. This plan consists of near-term, medium-term, and long-term items and provides a blueprint for the next 4-5 years. It is a living document which has already been updated several times in the interim and will undergo further revision when there is a new 'point' to add or an existing 'point' requires modification. An update on its implementation will be provided at the January 2025 congregational meeting.

# Fundraising

A central component of the plan is fundrais-

ing in support of the operating budget, a multipronged approach to which is laid out in the multipoint plan. Implementation of the fundraising component began in earnest in 2024. It includes: the sale of prepared food by the Food Fest team; a gala dinner held in September 2024; a helping to Run-the-Church-for-a-Day initiative, the Eclectic Christmas Market held in November 2024: and the well-established Shopping Card program. The combined funds raised for the operating budget in 2024 is \$34.5 K. Such progress on fundraising is attributable to many contributions of various types: donation of time & talent by numerous volunteers; cash donations; and purchases by the FSA community. Thanks for your generous support of these initiatives in 2024!

### Committee Changes

In early 2024, Council formally approved the creation of the Faith Formation Committee which is the union of the Worship and the Christian Development Committees. These committees had been meeting jointly for over a year as a pilot project. Council also approved a name change for the Mission and Outreach Committee. It is now simply the Outreach Committee. This change came the request of the Committee.

# Information Technology Makeover

FSA's Information Technology (IT) infrastructure (computer hardware, software, internet) and how it is managed had become increasingly problematic over recent years. There was a dire need for equipment replacement and a coherent management paradigm. On behalf of Council, FSA member Terry Peters undertook a very thorough audit in the period November 2023 to January 2024 and prepared a comprehensive action plan based on his findings. After approval by the Executive early in 2024, the action plan began to be implemented in step-by-step fashion under Terry's guidance. Implementation is now complete and all systems are 'go'. Thank you, Terry!

### **Exploring Redevelopment of Church Property**

At its March meeting, Council received a report from the Chair of the Planning Committee concerning FSA's interactions with an organization called Kindred Works. This initiative is being led by the Planning Committee augmented by others (e.g., Chair of Property, Chair of Council, and a few more). Kindred Works (KW) is an organization created by the United Church of Canada to partner with churches in redeveloping church property to provide an income stream for the church while simultaneously providing a mix of affordable and market-based housing. KW is building a nationwide portfolio of mixed-income rental housing and gathering spaces being developed in collaboration with individual churches. Initial discussions between FSA and Kindred Works have taken place. KW is currently undertaking a feasibility study to look at what is possible on the FSA property and provided an interim report in April. There is no charge for the study. Completion of the feasibility study is not anticipated until mid 2025. Once this study has been received and vetted by Council, an update will be provided to the congregation.

#### Introduction of The Eclectic Christmas Market

In late May 2024, I received, as Chair of Council, a notice from the UCW Executive stating that they had passed a motion transferring the annual fall Bazaar from a UCW-sponsored event to a Council-sponsored event. The FSA Executive Committee considered this matter in July 2024 and expressed that it would be desirable to continue this event and agreed that it could operate under the greater auspices of Council provided a Convenor or Co-convenors could be found. Fortunately, two people stepped forward on short notice as Co-convenors: Ardath Finnbogason-Hill and Tara Gonder, both experienced fall Bazaar veterans. Under the leadership of Tara and Ardath table coordinators and volunteers were recruited, sales tables were rented to local artisans, Ark Aid was identified as the beneficiary of 50% of the net funds raised, and the event was

renamed The Eclectic Christmas Market. Thank you Ardath and Tara!

### Guiding FSA to the Future

At the September meeting of Council, a set of five key strategic priorities to guide FSA into the future were adopted. These priorities are:

- continue to expand our path to become a more inclusive and welcoming community of faith
- take deliberate and purposeful steps to explore and enter on-going partnerships with other communities of faith
- take immediate action to adopt and use the United Church of Canada Vulnerable Congregations Assessment tool on an on-going basis
- take immediate steps to explore and engage in opportunities to redevelop the buildings and property of FSA
- take immediate steps to research and report on alternative church governance models

The full report is available on the FSA website from a link on our COUNCIL page. Actions to launch implementation of each priority have been taken. Ongoing activity is necessary for these priorities to have traction. Activity is being coordinated by the Chair of the Planning Committee (Steve Elson) and regular reporting to Council is anticipated. Thank you Steve!

# Vulnerable Congregations Assessment Tool

At the beginning of January 2025 a town hall style meeting on the 2025 operating budget was held after the worship service. The purpose was to provide an early opportunity to review and discuss a working draft of the 2025 budget, and introduce the congregation to the Vulnerable Congregation Assessment Tool provided by the United Church of Canada. At the annual congregational meeting at the end of January 2025, a final draft will be presented for approval. Council began using the fall of 2024 and plans to update the input data on a regular basis in order to track the 'vulnerability' of FSA.

#### Gratitude

As Chair of Council, it has been my privilege to work with scores of dedicated individuals who served faithfully on Council, standing committees, subcommittees, ad hoc task groups, search committees, and FSA organizations in 2024. It has equally been my privilege to work with our leadership staff and office staff. The staff support provided to me in the Chair role is strong and constant. The supportive engagement of the staff team with Council makes FSA stronger. To each volunteer, each Committee member, each member of Council, and each member of staff, I express my appreciation and offer heartfelt thanks.

#### Music

# Afghan Refugee Support Group

It has been a big year for the Afghan Refugee Support Group! After close to three years of filling in applications, fundraising, and waiting, some of the family has arrived in London! Three family members arrived in July, and one more came recently at the end of November. We continue to await 2 more family members whose applications are still being processed in Pakistan.

A lot has been accomplished in settling those family members who are here. The family is living in a lovely three-bedroom townhouse, well furnished with the many donations of furniture and household goods which we have gratefully received. They have health cards and social insurance numbers. They have a family doctor and have had appointments to have their health needs met. They have had dental appointments at the Wright Dental Clinic. They have bank accounts, cell phones, a computer and internet. The family has been connected to a settlement worker at the Cross-Cultural Learner Centre which has been helpful. They attend English classes daily and are considering job and educational opportunities. In fact, the eldest brother has recently obtained a part-time job at a nearby fruit market. So impressive! The family is becoming more independent in attending appointments and moving around the city on their own.

The many donations we have received have been crucial in helping this family find a safe home in Canada. Many thanks to all who have donated. I am so grateful for the dedicated work this committee has done to assist this family. Many others at FSA have also made a big difference in their lives and we are so thankful to everyone. The family frequently express their thanks and appreciation for all they have received and feel blessed to now be living in Canada.

Our fundraising for this family is ongoing! Maple Syrup sales continue! Please contact David McKane or the church office to buy Maple Syrup and support the family in this way.

Our need now is for help driving the family to appointments and meeting other needs as they arise. Any offers of help are appreciated without a need to join the committee. Please contact Linda Badke.

#### Canadian Foodgrains

First-St. Andrews and St. Marys United Church once again held their joint Grow-a-Row campaign in support of the Canadian Foodgrains Bank. The campaign ran for 8 weeks and our members contributed \$4,550 during that period. The FSA total was lower than last year, but we did not hold a corn roast this year as it would have been in the same time frame as the church's gala dinner fundraising event. However, the total proceeds between the two churches from donations plus the sale of the soybean crop totalled \$11,480, which is comparable to last year's campaign total and still a big increase over our 2022 campaign figures. This figure will be matched 4:1 by the Canadian Government. Thank you to our generous FSA supporters of this important initiative to combat global hunger and food insecurity.

#### Christmas Share, 2024

Christmas Share was very successful this year. We received 35 donations totalling \$5,455.00! This includes a very generous donation of \$1,000 from the London Interact club, the high school Rotary group that Linda Badke leads.

We are so grateful to all those who donated.

Christmas Share supports East London United Church Outreach, known as ELUCO, which works to stand by those in need in the Marconi community of east London through their Community Outreach worker, Nancy Howard.

We also greatly appreciate the Shopping Card Program at FSA for their support of Christmas Share and ELUCO. They make it easy for donations to be made. Shopping Cards and donations made at the Shopping Card table are given to Nancy Howard for the ELUCO Christmas Share Program. Nancy uses the donations to buy needed Shopping cards from FSA, which is a benefit to FSA. These cards are then distributed to families in need in east

London, helping to make Christmas a more joyous, hopeful celebration for them. Many thanks!

# East London United Church Outreach (ELU-CO)

ELUCO is an incorporated, Outreach of the United Church, Antler River Watershed London Regional Council, Ontario, supported by four United Churches in London: Siloam, Rowntree, Richards Memorial and First-St Andrew's United Churches.

'The simple truth.....We all just want to be accepted, respected, appreciated, heard and loved' (Samantha Woodbeck). This sums up exactly what ELUCO is about. Nancy Howard, ELUCO's Community Outreach Worker and the face of ELUCO in the Marconi Low Income Housing Community in East London, feels that the personal care and attention offered by ELUCO to the community is what sets ELUCO apart from other agencies.

During 2024, the following continued to be key issues facing individuals, families and children living in the Marconi Low Income Housing community, East London. Food security escalated during the past year due to a 4.5% increase in the price of food. Mental health issues continue to plague the community. Nancy Howard, the ELUCO Community Outreach Worker offers support & counselling. Supporting United Church congregations, UCW groups, youth groups and individual donations allows distribution of school supplies, toiletries, grocery gift cards. ELUCO supports many families with LMCH, OW, ODSP, Housing Stability, and Housing Access documentation and support during meetings. The ELUCO Gethsemane Food Cupboard operates by volunteers out of the Gethsemane Gardens Housing Complex and is open to clientele Wed. and Fri. mornings from 9:30am to noon. By the end of Nov, 2024, the Food Cupboard has served 584 families (2023, 467 families in total). This increase is a reflection of the increase in food prices. Sisters

of St Joseph and London Food Bank support this initiative. **Welcome Wednesday:** Once/month ELUCO volunteers serve a noon day meal at Rowntree United Church. Approximately 45-50 individuals attend.

**ELUCO Community Outreach Worker Change to Part Time Hours**: The ELUCO Board of Directors has had to make the difficult decision to reduce the Community Support Workers (Nancy Howard) hours from full time to part time (20 hours/week), effective Jan 1, 2025. By reducing ELUCO's financial commitment, the Board is ensuring the continuation of ELUCO's important work at the Marconi Housing Community in the areas of food security, advocacy, family counseling & support, and seasonal fund raising under the caring and effective guidance of Nancy Howard. The ELUCO Board of Directors thanks you for your understanding and continued, on-going support.

# The Jean and Bill Knowles Outreach and Social Justice Endowment Fund:

From its early days at FSA this committee has contributed to the needs of 500 at-risk school children including food and educational/school supplies. Los Quinchos also receives a grant from the United Church of Canada Mission and Service fund.

#### **United Church Mission & Service Fund**

We informed the congregation of the work of the United Church Mission & Service Fund through *Tidings*, eblasts and monthly Outreach Moments. This fund represents who we are as a church supporting social justice initiatives locally, nationally and globally. We thank FSA members who contribute to this important Fund. Our Mission Sunday speaker this year was Pam Cullen, chaplain and Executive Director of the London Community Chaplaincy which provides support to children and families living in two of the largest low-income housing complexes in London in the Southdale and Limberlost areas.

#### St. Paul's Social Services

We continue to support St. Paul's Social Services with monetary and non-perishable food donations to their daily food bank which welcomed many new clients who have not needed help in many years. They provide an emergency three-day supply of food including fresh eggs, powdered milk, peanut butter, canned fish and fresh produce.

The Fellowship Centre of St. Paul's Social Services serves guests hot lunches every Thursday. The meals consist of a choice of homemade soup and freshly-made sandwiches, with the frequent addition of fresh fruit salad.

### White Squirrel Golf Tournament

The Outreach Committee extends its sincere thanks to all those who so generously contributed to the success of our 18th annual White Squirrel Golf Tournament in June this year. FSA members and over 20 Hole Sponsors helped us reach our goal with generous donations. Our net proceeds were \$12,600. The beneficiaries of these donations were: ELUCO (East London United Church Outreach), Indwell and Ark Aid Street Mission which each received \$3800.00 as well as St. Paul's Social Services and Los Quinchos school in Nicaragua which each received \$500.00.

#### **PROPERTY**

irst St Andrew's United Church is an historic structure which requires regular care to ensure its viability for generations to come. The Property Committee has been meeting monthly via zoom to address ongoing maintenance issues, Avis Report deficiencies and unexpected occurrences. The committee is dedicated to both maintenance of, and improvements to our church home.

The Property Committee has completed our first full year with the absence of a Facilities Manager. The Property Committee and some dedicated volunteers have contributed extensive volunteer hours to manage facility needs as efficiently as possible. Many thanks to those who assist in this capacity. The resulting savings to the Operating budget are significant. This year we also saw the retirement of our regular custodian, Lynda Cooper, who provided excellent service for many years. We are currently working to train a replacement.

Our building has experienced a growth in regular use. In addition to our own full slate of program uses and concert events, El Sistema, Original Kids and the Nepalese Church have placed increased demands on the building. So far all of our users seem to be able to work in

the building in a collaborative manner. We understand and appreciate that balancing the needs of multiple users is demanding and requires flexibility. However, the rental income stream largely covers all property operating expenses and justifies any inconvenience. Having said that we believe the building is currently being used at capacity.

The Property Committee did undertake several projects as they became necessary:

- Motion Sensor light switch in single bathroom
- Painting, small bathroom, new electrical closet, Farguhar House front porch
- · Rebuild retaining wall in Alcove
- Boiler System Startup annual inspection, cleanout and water testing (Capital)
- Kitchen repairs, stove, dishwasher
- Alcove Security Fencing (Capital)

# Heating System

Maintaining our current heating system has become a priority. This year we experienced significant boiler issues which required remediation. The committee continues to engage in planning for a replacement heating system. Green options remain a primary focus for an older historic structure such as ours especially in light of the recent increases in utility costs. The heating system was identified by the Avis report many years

ago as being due for replacement. Once again repairs were undertaken as required. A steering Committee is currently working to research options and make recommendations regarding HVAC changes for the future. This will be a major topic of discussion in the next year.

#### **Committee Members**

We currently have two vacancies on our committee, one member at large plus the Facilities Staff position. Current members include: George Jolink (Chairperson); Heather Vouvalidis, Bill Guthrie (Secretary), Peter Ross, Ron Bradley and Connor Campbell.

#### **FINANCE**

he Finance Committee has reviewed a preliminary version of our internally generated financial statements for 2024. Externally reviewed statements will be available for Part 2 of our Annual Meeting later this year.

Like many churches FSA faces challenges as revenue declines and expenses increase. However, we have seen many positive developments in 2024 that we have the opportunity to leverage as we build Financial Plans in future years.

# Revenue Donations

We want to thank our donors who provide most of our Revenue. We especially want to thank our members who donate by PAR and stock donations. PAR Revenue now makes up 75% of our Offering - thank you for this consistent monthly income!

Total donations including Fundraising and Memorial Donations totaled \$367,641 in 2024

and were \$9.4K ahead of budget. Revenue is declining year over year. For the first 3 Quarters of 2024, Envelope and Par Givings were ahead of 2023 by 3%. However, in Q4 they fell behind 2023 by 19%. Seasonal appeals fell below 2023 by \$7,950. Overall, Envelope/ Par, Seasonal Appeals and Other Givings decreased 7% from 2023 to 2024.

Work has begun to gather data regarding trends in givings, and in particular, PAR donations. We will use this analysis to better forecast financial results and cash flow in the future. We are losing long-time members year over year. As new members become more engaged, they will be more likely to donate more. However, we must consider that external challenges like increased cost of living and reduced disposable income and competing priorities will contribute to a reduction in both the number of regular donors and givings per person.

#### **Fundraising**

We are very grateful for our volunteers who help to organize fundraising projects. Donations of talent and time have been paramount to the success of these initiatives. As a welcome new revenue source for 2024, fundraising contributed \$25,763 to Operations. Although there are still opportunities to increase this revenue stream in the future, it will require more volunteers to support and sustain these initiatives.

#### Rental Income

Our rental income from both one-time events and on-going lease agreements continues to be vital to our sustainability and has increased by 8% from 2023 to 2024. We are grateful that Meals on Wheels and El Sistema continued use of FSA space. In 2024 a long-term rental agreement was negotiated with a fledgling congregation from the Nepalese community in London. These agreements have provided a consistent and valuable monthly revenue stream.

Our building has also been busy with other

rentals throughout the year beyond our expectations for 2024 and the use of the building has likely reached capacity.

#### **EXPENSES**

### Compensation

Investment in our Ministry and personnel has allowed us to successfully develop programming and increase engagement within our congregation and the larger community. The surpluses or close to breakeven financial results reported in recent years are in part due to staffing vacancies. In 2024 functions of the role of Facilities Manager which has been vacant since July 2023. were filled by volunteers. Our Youth and Young Adult Minister, Marilyn Arthur vacated her role in October 2024. This vacancy has been taken as an opportunity to conduct a needs assessment to develop an appropriate role going forward. The impact of any new roles or changes in positions on the budget will be carefully evaluated but consideration will also be given to continuing the momentum that our programming has experienced with our investment in staffing.

We assume our current Ministries and all our programs will continue. UCC recommends a COL increase for Ministers at 3.0%. Roles are evaluated regularly and budgeted by M&P to increase accordingly. Other Allowances such as Mileage and Telephone and Continuing Education make up our total M&P expense. Continuing Education is funded by the Clark Fund and \$3,271 for was utilized by staff in 2024.

### **Property**

Property Expenses are the second largest Expense in our Budget. The Property Committee prepare a very detailed Budget for both the fixed costs (such as utilities) and for additional Building Maintenance Projects. Taxes, Insurance and Utilities comprised 67% of Property Expenses in 2024. This coming year we will be attempting some building repairs that have previously been put off for years due to budget constraints. Capital Expenditures in 2024 totaled \$45,498.

#### Music

In 2024 Music Expenses were \$20,494. Year over year increases have been curtailed by assistance from Friends of Music in the amount of \$3,700 for concert related soloist rehearsals and \$2,400 from the Music Trust Fund.

#### Administration

Administrative expenses increased by 16% from 2023 to 2024. These increases are largely driven by increases in monthly charges for service contracts and service charges as well as investment in ITS infrastructure.

#### **UCC Assessment**

This amount is determined by UCC based upon their formula that uses our financial information from 2 years prior. In recent years, our Assessment has been:

- 2022 \$23.841
- 2023 \$33,657
- 2024 \$31967
- In 2025, the Assessment is set at \$20,327

#### **CASH ON HAND**

At Dec 31,2024 our bank balance was \$126,183. Of this \$68,335 reflects a cumulative Operating Reserve. The remaining funds are restricted and not available to spend on Operational Expenses. FSA needs to have sufficient cash flow coming in from various income sources and going out to pay expenses and other obligations when they are due and monitoring our balances is crucial. The reconciliation below illustrates how our preliminary cash surplus reported for Dec 31, 2024 relates to the cash available in the bank.

#### YEAR-END FINANCIAL RESULTS 2024

Although December 2024 results are not final, we initially project a financial break-even. This is great news and a much stronger financial performance than expected, when compared to a budgeted deficit of \$91,912 after Proudfoot Fund support of \$100,000. Total revenue exceeded budget by \$19K and total expenses were \$62K less than budget. Staff vacancies, less than expected expenditures for ITS initiatives and a delay in some larger property maintenance projects contributed to this.

#### Trustee Assistance

Previous year surpluses and Trustee support reduce financial burdens in order to sustain operations.

The Trustees hold an investment portfolio on our behalf. Each year, the Trustees deliver the Return on the Investments to our Operating Budget. The Trustees provided the following assistance to directly offset Operating expenses in 2024.

- Proudfoot Fund (Operations): \$107,500
- Proudfoot Fund (Capital): \$45,498
- Pastoral Care Salary Support: \$20,000
- Jean Brown Fund (Programming): \$748

- Jean Brown Fund (Salary Support): \$27,576
- Clark Continuing Education Fund: \$3,271
- Knowles Fund (MO Special Outreach): \$5,500
- Music Fund: \$7,390

#### Financial Health

FSA's financial challenges are not unique but new opportunities have allowed us to envision a bright future. This will be the work of the entire congregation. However, evaluating the success of the church solely in terms of the amount of funds it raises and simply measuring the size of its congregation undervalues its contribution to the whole community.

Fortunately, FSA continues to benefit from both the generosity of its members, income earned by the Board of Trustees (primarily The Proudfoot Fund), as well as the mindfulness of committees to curtail expenses or develop new revenue sources when appropriate. This has allowed us to minimize deficits and to continue to live as stewards of God's abundant gifts through Faith, Service and the Arts.

## **MINISTRY AND PERSONNEL**

he Ministry and Personnel Committee manages all FSA staff. Our goal is to create and maintain a high level of staff performance within a work environment that promotes individual well-being and harmonious relationships. Each staff member, full or part time, is paired with an M&P liaison who serves as a channel of confidential communication between the staff member and the M&P Committee.

The role of the M&P Committee was detailed in a recent edition of the FSA *Tidings*.

The year 2024 saw one staff resignation and a contractor retirement.

Marilyn Arthur, Youth and Young Adult Coordinator, resigned to take up a full-time post as a congregational minister. Marilyn received her Diaconal Minister designation this year. Unfortunately, Siloam United Church pulled out of the three-church partnership that employed Marilyn; FSA and Metropolitan were unable to pick up the one-third portion of Siloam's financial responsibility, leaving Marilyn with a part time job. Much effort was expended by both Marilyn and FSA to try to recruit other congregations to the youth partnership, without success. The future of youth programming is still under discussion. We are very grateful for Marilyn's contributions to our youth during her time with us.

Lynda Cooper, our contract custodian for several years, retired in November. Lynda worked three mornings a week to help keep our church sparkling clean. Thank you, Lynda.

Our minister of Worship and Congregational Life, Pastor Joshua, continues to bless us with inspiring worship leadership, and has established collaborations with several other churches and community organizations to reach out to the disadvantaged in the London area.

Our two Chrises, Fischer and Lindsay, have not only settled well into their jobs since joining us, they have excelled! Our music program has grown and prospered under Chris F's leadership as Minister of Music. The children's Sunday participation has increased significantly due to Chris L's enthusiastic leadership as our Children's Program Coordinator.

Our longest serving staff, Office Manager Kathryn Skelly, continues to provide great support to staff, FSA members and visitors. Kathryn's formal job description now includes all aspects of her work, including that related to live streaming of FSA services and concerts.

Pastoral Care Minister Annie Jannaway has now been with us for eighteen months. Her gentle manner combined with her many years of experience in various aspects of caring for people has brought excellence to her position.

In 2024, we completed a major revision to the FSA Employee Handbook, which was subsequently approved by Council; it is posted on the FSA web site. Regular staff evaluations were carried out for each staff. We hosted the annual staff appreciation lunch and, at Christmas, provided a small gift to each employee as an extra token of our appreciation.

Finally, I am very thankful for the valuable contributions by my fellow members of the Ministry and Personnel Committee. We are a working committee: members take on special studies, liaison roles, and participate enthusiastically in discussions of significant issues. Special thanks to Kathryn Patton who retired from M&P during the year. Kathryn was a long-time member of M&P. Her thoughtful contributions to our discussions and our monthly "reflections" agenda item have served M&P very well.

In the fall, we welcomed Alex Neaves to the M&P committee, adding an important legal perspective to our work.

## **BOARD OF TRUSTEES**

he Board of Trustees holds title to and administers all property owned by First-St. Andrew's United Church for the benefit and use of the congregation as part of The United Church of Canada under the provisions of the *Trusts of Model Deed* of the United Church Manual. The Board is also the registered owner of the freehold title to the lands upon which the church sits.

The Board of Trustees held three regular meetings in 2024. There are four Committees accountable to the Board of Trustees: Insurance,

Investment, Long-Term Giving, and Memorials. At least one member of the Board serves on each committee. Meetings of the various Trustee Committees also took place during the year, and Trustee members also attended and made presentations at the Annual Congregational Meeting, at regularly scheduled Council meetings, and the Co-chairs sit on the Council Executive.

During 2024, Trustees included: Paul Cooper (Co-Chair), John Eberhard (Chair, Long-term Giving Committee), Janice Elliott, Don Jones, Bob Kennedy, David Manness (Chair, Investment Committee), Barbara Plante, Alan Salmoni (Chair, Insurance Committee), Jim Silcox, David Wake (Secretary), Jackie Williams (Co-Chair), Katherine Wonfor (Chair, Memorials Committee), Kenneth Wright and Rev. Dr. Joshua Lawrence (ex officio). Invited guests to the Trustees meetings during 2024 have been: George Jolink (Chair of Property), Laura Wood (Treasurer, Chair of Finance), David Wardlaw (Chair of Council) and Steven Elson (Past Chair of Council).

The Board manages the Proudfoot Legacy Funds, made up of the Proudfoot Legacy Restricted Fund, the Proudfoot Legacy Unrestricted Fund, and other Funds restricted as to their use by their donors. We are very pleased to report to the congregation that in 2023 the two new Restricted Funds established by bequest: the Jean & Bill Knowles Fund for outreach projects, and the Pastoral Care Endowment Fund, have done well financially. We can all feel blessed and deeply grateful for the foresight of the many individuals who have supported First-St. Andrew's through donation of these funds over the years.

In December, the Investment Committee reported that, without exception, all Trust Funds are above their Principal values. Of course, each financial year can end well, with the New Year bringing gloomier forecasts. This makes continuous monitoring and adjustments by the Investment Committee necessary to optimize FSA's Trust Funds over the long term.

The Trustees work closely with the Finance Committee, and the final reports, and the approved financial statements from the Trust Funds will be presented at the subsequent Congregational meeting together with those of the FSA operations.

In 2024, at the direction of Council, the Board of Trustees made available \$212,698 from the Proudfoot Legacy Fund to FSA for Operations. This included over \$38,000 for capital expenses

approved by the Trustees, most notably, boiler repairs to keep FSA's heating system operational for as long as possible. It also covered such expenses as new flooring for the Fireside Room, more security fencing to prevent vandalism, air conditioning for the Minister's office, and new microphones.

As Chairs of your Board of Trustees, we greatly appreciate the efforts of our fellow Board members and of you, the members of our congregation. We anticipate a busy 2025, looking after our fiduciary responsibilities on behalf of the congregation and managing the funds that are so important for our ability to do God's work in this great community.

We offer many thanks to David Manness, who is rotating off the Board of Trustees after seventeen years of service, twelve of which he served as Co-chair, alongside John Eberhard. He is also stepping down from his role as Chair of the Investment Committee but has generously volunteered to stay on this committee in an advisory capacity.

We welcome three new members to the Board this year. Kenneth Wright is a long-term member of FSA, with extensive experience in fund raising. Heather Vouvalidis also is a long-term member of the church, and served for a time as FSA's Office Administrator. Tony Parker became a member this year and has graciously agreed to become our next Chair of the Investment Committee. Tony retired from the Bank of Montreal in 2012 after a 37-year career. During the last 20 years of his career he was a Private Banker in the Private Banking division. We are blessed to have these exceptional individuals as new members of the Board of Trustees.

In closing, we remember John J. Eberhard, an invaluable member of the Board of Trustees for seventeen years, twelve of them as Co-chair, who died in November of 2024. John's many contributions to this Board and to FSA are legend
